Introduction

The Dementia Services Development Centre (DSDC) sits within the Faculty of Social Sciences and is an international centre for knowledge exchange, whose purpose is to improve lives for people living with dementia.

Since our formation in 1989 we have worked with individuals and organisations to: improve the lives for people living with dementia; make communities dementia friendly; and influence policy to improve services for people with dementia.

At DSDC we pride ourselves on our international reputation as leaders in the field of dementia design. Our team of architects, engineers, designers and healthcare professionals advise on products, services and the design of environments where dementia matters. This includes provision for older people, for palliative and end-of-life care, as well as design specifically for older and working age people diagnosed with dementia.

Our specialist team has worked on projects internationally on the design and delivery of healthcare, social care and housing to support people with dementia – on large scale new build projects and smaller scale refurbishments. We offer a range of services, which are designed to provide advice and support across the design development of a project through to completion and where desired, to accreditation.

Design Training

Our team are skilled facilitators of professional training in dementia and design. DSDC provides regular online training at both an introduction and advanced level. Online learners can access the training materials over a number of weeks at a time that works for them.

DSDC also offers a free one hour RIBA CPD assured training video, which provides an overview to dementia and the principles of dementia design.

Introduction to Dementia Design

A starter course aimed at staff who need to understand the importance of design for people with dementia but do not have a direct role in influencing design. This programme can also provide an ideal starting point for teams about to embark on a new venture. Learners have access to the course over a four week period.

Intersection of Dementia + Design

This course will develop your knowledge of the key principles of dementia-friendly design which is seen as one of a set of non-pharmacological interventions for people with dementia. Therefore any setting for people living with dementia should be dementia friendly to optimise the treatment outcomes for all interventions.

The course is delivered over seven weeks, although learners can access the course content for 12 weeks. We would recommend allocating two hours each week to complete the course.

Course syllabus:

Week 1: Introduction to DSDC, dementia and the dementia design principles.

Week 2: The individual with dementia

Week 3: Interior specification

Week 4: Hearing and sight

Week 5: Outdoor spaces

Week 6: Mechanical and electrical

Week 7: Neighbourhoods and the urban realm



Design Audit and Accreditation

The Environments for Ageing and Dementia Design Assessment Tool (EADDAT) is a highly-respected series of resources for carrying out self-assessment of environments used by people with dementia. The tool is split into three tiers, each reflecting the scale of the intervention or project.

Tier 1 - is the entry level, ideal for those wanting to make small changes.

Tier 2 - is the intermediate level, which is split into seven versions to cover a range of building typologies and settings.

Tier 3 - is still under development, but will be our most comprehensive tool.

Accreditation:

Tiers 1 and 2 offer users with the option to undertake a self-certification. Users with a successful self-certification can opt to receive a window decal and certificate. Alternatively, Tier 2 users can request an official DSDC audit, which leads to an independent award. An official audit accreditation goes further than a self-assessment, and has proven of great practical and reputational value to organisations. An audit includes:

- An assessment visit by expert auditors
- A detailed report providing feedback on areas of design in the building, advice on suggested improvements and a rating of Bronze, Silver or Gold (providing building meets requirements)
- A certificate from DSDC valid for 3 years
- Costs - £4,325 + VAT + expenses

Plan and Scheme Review

DSDC offers a cost-effective, electronic way to ensure plan and design scheme proposals meet design criteria set out in the Environments for Ageing and Dementia Design Assessment Tool (EADDAT). This is ideal for clients seeking independent advice on the appropriateness of design proposals.

Plan and scheme reviews are best undertaken at the initial concept design stage to ensure recommendations can be considered and adopted with minimal cost and time impact to the client and their design team. A more detailed plan review is available for detailed design / tender stages of a project.

Clients receive a written feedback review within 4-6 weeks. We can also arrange a follow-up meeting.

The Iridis 'app' and BIM platform

In September 2017, the DSDC launched 'Iridis'; a digital app to help assess and improve environments for people living with dementia.

This software has been created to promote a better quality of life for people with dementia and represents a revolution in the implementation of dementia design principles in homes, workplaces, care facilities and public buildings. The app allows homeowners and professionals to assess the built environment against our Dementia Design Audit Tool (Cunningham et al, 2009) and provides cost-neutral recommendations on improvements.
